#### **RULES AND REGULATIONS**

#### 1. NAME OF THE ORGANISATION : RISE KRISHNA SAI GANDHI GROUP OF INSTITUTIONS ALUMNI ASSOCIATION

2. ADDRESS

: ASSESMENT NO - 551 RISE KRISHNA SAI GANDHI GROUP OF INSTITUTION VALLURU VILLAGE, TANGUTUR (M), PRAKASAM DIST.

#### 3. AREA OF OPERATION : ENTIRE ANDHRA PRADESH.

#### **RULES & REGULATIONS :**

- 1. The students of the college are eligible and after completion of 18 years of age and abides by all the Aims & Objectives and the Rules of the Society is eligible for the Membership every member shall pay annual subscription Rs. 50/- to carry and the functions of the society. The enrollment of membership to any person in subject to the acceptance of the executive committee.
- 2. Any person may be admitted by the Governing Body as a Member on receipt and written application and the Governing Body is vested with absolute powers of admission or refusal of admission without assigning any reason whatsoever.
- Any person shall cease to be a Member (a) by resignation (b) by death (c) by removal by the Governing Body through special resolution on grounds of indiscipline (d) by absence to the meetings consecutively for 3 times.
- 4. Constitution of the Governing Body : The Governing Body shall consist of 11 Members
  - 1. President 1 Vice President 2. 1 1 3. Secretary Joint Secretary 4. -1 5. Treasurer 1 6. E.C. Members -6
- 5. The Office Bearers and the Members of the Governing Body shall be elected by the General Body and hold office for a period of three years or until their successors are elected.
- 6. The casual vacancies caused among the elected members shall be filled in by the President from among the Members of the General Body and such members, so joined, shall retire along with the other office bearers holding the office for the remaining period only.
- 7. The President may constitute a Board of Honorary Advisors to the Institutions sponsored by this Society. The Board of Honorary Advisors shall be an autonomous body dealing with academic matters. The term of office of the body is three years.

- 8. The President shall appoint a person to his choice as correspondent(s) of the Institution or Institutions to deal with day-to-day administrative matters.
- 9. The Correspondent shall attend all the administrative and financial matters of the institution or institutions under the direct control of the President.

### **POWERS OF THE PRESIDENT :**

The Prisedent shall look entire administration and in all the activities and projects and programmes undertaken by the society The President for and after him there the President shall be elected by the General Body along with the Office Bearers. He/she shall preside over the Meetings.

He/She shall have a casting vote in addition to his/her own, in case of a tie in the meetings. He/She shall operate Bank or Banks account / accounts or authorise any person appointed under 12(a) to operate the Bank / Banks, Account / Accounts. He/ She shall operate Bank Accounts jointly with Secretary.

#### VICE-PRESIDENT :

In the absence of the President the Vice-President shall preside over the Meetings of General Body and executive Committee and perform all the functions of the President.

#### SECRETARY :

. He shall maintain all the Records and Accounts of the Society.

- a) He/She shall convene the meetings of the Governing Body or General Body with the consult of the President.
- b) He/She shall send notices of the Meetings of either bodies.
- c) He/She shall be the Custodian of all the records of the society.
- d) He/She will be the Controller of the Finances and se/She is at liberty to appoint any person on his behalf as Controller of Finances to his/her choice.
- e) He/She shall have the control over all the affairs of the society and shall be responsible for all the merits and demerits of the society as well as the institutions. He/She shall sue or be sued on behalf of the society and institution.
- f) He shall operate Bank Accounts jointly with Prisedent.

#### JOINT-SECRETARY :

He/She shall perform the duties of the secretary during the absence of the secretary on written request.

#### TREASURER :

He/She is the responsible person of the financial transactions relating to the Society. He/She has to maintain accounts properly along with the vouchers. He / She has to prepare the budget expenditure statement of the society with the guidance of President.

#### EXECUTIVE MEMBERS :

All the Executive Members of the Association / Organisation should compulsorily attend the E.C. Meeting is conducted, and express their opinions for the uplift of the Association.

#### GOVERNING BODY :

- (1) The Governing Body shall meet often or at least once in three months to consider the accounts and transact such business as may arise for consideration.
- (2) The body may be convened on the requisition of any three members of the Governing Body specifying the agenda of the Meeting. Such requisition meeting shall be convened within 15 days from the date of receipt of the requisition.
- (3) There shall be 3 clear days notice with date, place and time together with the agenda for ordinary Meetings and in case of urgency, the Members may be called for through a Telephone Call, Messenger or Personal.
- (4) The Governing Body is vested with absolute powers to sell, improve, develop and exchange, lease or let out under lease or sub let, mortgage, dispose off, turn to account or otherwise deal with and manage with all or any part of the properties of the society.
- (5) The Governing Body shall consider the Audited Accounts and forward their opinion on the administration and financial matters of the society and the institutions to the General Body for consideration.

#### GENERAL BODY :

- (1) The General Body shall be convened once in a year ordinarily in the month of April to consider the Audited Statements and al the Matters forwarded by the Governing Body. The body shall be convened within one month on receipt of requisition with Agenda from 1/6<sup>th</sup> of the total eligible members of the General Body. Meeting particulars shall be informed to the Registrar within 14 days.
- (2) The General Body shall elect the Office Bearers and the Members of the Governing Body to held their Office for a team of three years.
- (3) All the Resolutions are passed with a simple majority vote and in case of tie, the President shall have a casting vote in addition to his own.
- (4) The General Body Meeting shall be held on the same date of the next month at the same place and time, when the quorum is in-sufficient to conduct the business as noted on the notices sent to Members and no further notice is necessary for such Meeting of the next month and such Meeting shall consider the Agenda irrespective of the Quorum and all resolutions passed in the said Meeting are deemed to have been passed by all the Members of the General Body.

- (5) The Minutes of every Meeting shall be recorded in a Book specially kept for the purpose and the same shall be signed by the President at the end of the Meeting.
- (6) The Governing Body may remove the primary membership of any member from its rolls with 3/5 majority of Members present, when the activities of such person/persons are found detrimental to the interests / of the society or the institution.
- (7) The General Body may consider any subject that may be brought into the Meeting by the Secretary with the permission of the President.
- (8) Any member failing to attend the three Consecutive Meetings shall cease to be a member automatically.

#### **QUORUM**:

The Quorum for a Meeting shall be 3/5 of the total eligible members.

#### AMENDMENTS :

The General Body shall have the power to add / alter / replace / change / delete any of the above (and shall be confirmed with 3/5 majority after one month article / articles with 3/5 majority of the total eligible members in a meeting specially convened for the purpose after one month. As per sec 12 of societies registration Act.

#### FUNDS:

The funds shall be spent only for the attainment of the objects of the Society and no portion there of shall be paid or transferred directly or indirectly to any of its members through any means.

A. The objective of the society is open to all-irrespective caste, creed, religion and sex.

#### LIQUIDATION:

The Society may take over any other Society or Association with similar objects and nature on request and such request may be considered and accepted by the Governing Body of the Society 3/5<sup>th</sup> Majority.
